Further, you are also informed that:



- You should also follow the instructions which will be issued in the academic calendar by this University for every academic year.

- 5 You should maintain minimum standards of the quality of education, environment of the campus of the college, infrastructural and instructional facilities to the pupils and further to develop the facilities for imparting education in future years.
- 6 The University has granted extension of temporary conditional affiliation to the College for a period of one academic year only i.e. for **2018-19** only. You should submit proposals separately, **for extension of affiliation for the academic year 2019-20 during February, 2019 in the Online Format (Annexure –II) along with affiliation and Inspection Fee of ₹30,000/- per each course payable through online challan system.**
- 7 The syllabus prescribed by the University for the above courses is placed on the University Web site **“www.svuniversity.edu.in”**. Advised to watch regularly the University website for any information.
- 8 The College Management should take necessary steps for constitution of the Governing Body and conduct the meetings as per Chapter XI of the Laws of the University at least twice in an academic year and send the minutes of the Governing body to the University.
- 9 Without prior approval of the University/APSCE & NCTE, you should not shift the building to any other new place/Change the management/change the name of the college / shifting the college from rural to urban and vice-versa.
